**SOUTH EAST MICHIGAN HEALTH INFORMATION EXCHANGE (SEMHIE)
WINS \$2,988,000 CONTRACT FOR ELECTRONIC MEDICAL RECORDS
FROM U.S. SOCIAL SECURITY ADMINISTRATION**

Detroit, Michigan, April 22, 2010 — The South East Michigan Health Information Exchange (SEMHIE) announced today that it has won a \$2,988,000 contract for an Electronic Medical Records (EMR) initiative from the U.S. Government's Social Security Administration (SSA). This award comes to SEMHIE in partnership with its Fiduciary, Southeastern Michigan Health Association (SEMHA), and its collaborative partners Sun Microsystems, CNSI, the Object Management Group™ (OMG™), and Computer Sciences Corporation. The funds will be used to automate the process of filing Social Security disability insurance claims in the Detroit Metro Region, and accelerate the process from 457 days on average to six hours. Once received - decisions on these claims can be made by SSA in days - providing disabled citizens financial support on a timely basis while bringing increased federal dollars to the Detroit area faster. On the larger scale, the infrastructure of this health information exchange will provide the start of the process for creating a comprehensive health information exchange for South East Michigan. The funds from this contract award will enable two major hospital systems that are collaborative partner members of SEMHIE, Henry Ford Health System and Oakwood Healthcare System, to link their systems to the Nationwide Health Information Network (NHIN). Ultimately, when additional funding is procured, the other four major hospital systems in the Detroit Metro area are expected to use the same infrastructure to provide a similar service.

Michael J. Astrue, Commissioner of Social Security, announced that 15 healthcare providers and health information exchange networks received \$17.4 million in contract awards to provide electronic medical records to the agency under the program. The funds allocated to SEMHIE represent 17.2% of all funds awarded nationwide under the program and two times more funds than any other health information exchange awarded contracts.

“Using health information technology will improve our disability programs and provide better service to the public,” Commissioner Astrue said. “We’ve seen a significant increase in disability applications. To process them, the agency sends more than 15 million requests annually for medical records to healthcare providers. This largely paper-bound workload is generally the most time-consuming part of the disability decision process. The use of health IT will dramatically improve the speed, accuracy, and efficiency of this process, reducing the cost of making a disability decision for both the medical community and the American taxpayer.”

The contract awards are funded through the American Recovery and Reinvestment Act (ARRA). They will require awardees, with a patient's authorization, to send SSA the specific electronic medical records through the NHIN. The NHIN, a safe and secure method for receiving access to electronic medical records over the Internet, is an initiative of the Department of Health and Human Services supported by multiple government agencies and private sector entities.

SEMHIE's strategic IT collaborative partners in the SSA project include Sun Microsystems, CNSI and Computer Sciences Corporation. These are three of the four entities which built the NHIN for the U.S. Department of Health and Human Services. The top scientists and architects at Sun and CNSI worked with SEMHIE's experts, including Program Manager Michael M. Talley, to architect the solution proposed to SSA. This solution incorporates a state of the art Service Oriented Architecture (SOA) and advanced mapping technology based on the Model Driven Message Interoperability™ (MDMI™) Standard of OMG.

OMG Chairman & CEO Richard Mark Soley, Ph.D., stated, "The OMG is pleased to be a part of the SEMHIE team that will provide the first of many innovative solutions for the citizens of Michigan and the SSA. Their insight that SOA architectures need to incorporate open standards from OMG is to be commended. I am confident that the OMG MDMI Standard will provide great benefit to not only SEMHIE, but that these efforts will be leveraged to provide value to the entire U.S. healthcare community."

Michael M. Talley, who holds the triple roles of SEMHIE's Treasurer, SSA Program Manager, and a member of the Board of Directors stated, "It is gratifying to receive this substantial support from the federal government to assist us in bringing our plans to life. I also want to thank University Bank President & CEO Stephen Lange Ranzini for the bank's substantial donation of in-kind financial assistance to SEMHIE which made this contract from SSA possible. I am very pleased that Oracle joined our Social Security proposal, which was successful."

Mr. Ranzini, stated, "Healthcare information exchange is critically important in helping solve the long-standing problems that have hindered the manufacturing industry in Michigan and contributed to the loss of one million jobs in Michigan since April 2000. Mr. Talley's efforts in the health information exchange industry have been supported by University Bank as a community reinvestment activity. The bank is providing SEMHIE with free office and conference meeting space to support SEMHIE's efforts. In my role as President of the Ann Arbor Economic Development Corporation I have also donated substantial time to mentor SEMHIE through this critical time during its start-up phase."

We are also pleased to be aiding the SSA's utilization of the NHIN and feel that getting the Southeast Michigan providers online will greatly reduce the cost and complexity of integrating additional providers to this HIE platform, thus accelerating adoption overall."

Helen Hill, SEMHIE Co-Program Manager for Public Private Initiatives, and Henry Ford Health System Director of IT Consulting and HIE, stated, "SEMHIE is pleased to partner with the Social Security Administration on this innovative project that will provide great benefit to the economically and medically distressed residents of Southeast Michigan by dramatically reducing the average wait time for a decision on eligibility for disability. This project will advance health information exchange significantly in this region, providing standards-based interoperability between major integrated healthcare delivery systems and an agency of the federal government using NHIN Connect. This is a good first step toward achieving meaningful use under ARRA for our region's and our state's providers. Henry Ford Health System, a founding member of SEMHIE, is very proud to be a project participant. This is the first of many public-private initiatives for SEMHIE as we move toward full implementation of our neutral, trusted health information exchange."

Karen Schmidt, SEMHIE Director of Medical Services, and Henry Ford Health System Director of Medical Record Services, stated, "Throughout the years Henry Ford Health System (HFHS) has partnered with Michigan Disability Determination, Social Security Administration to streamline the processes for providing medical records in order to benefit our mutual customers (the patients). The importance of the e-Disability Claims Project will enable HFHS to provide patient information much faster on the 12,000+ requests received annually; thus providing Disability Determination the ability to make faster determinations for our disabled citizens. Not only will this benefit the Michigan citizens it is also a win / win situation by simplifying the HFHS staff work load, and reducing the variance by providing standardized structure data to Disability Determination."

Paula Fusco Smith, SVP & CIO of Oakwood Healthcare System and the Vice Chairman of the board of SEMHIE stated, "This is a great step for Southeast Michigan and the SEMHIE organization. Oakwood is excited about being one of the leading health systems to initiate the health information exchange between the healthcare providers and Social Security Administration."

For the last year, Social Security has been successfully testing health IT to obtain electronic medical records. Disability applications processed with electronic medical records from the test sites in Massachusetts and Virginia have significantly reduced processing times. Some decisions are now made in days, instead of weeks or months. SSA expects to receive more than 3.3 million applications in fiscal year (FY) 2010, a 27
